1. Controller of the data

2. Information we collect

- Basic identifying information: your full name and email address, used to identify you as a user of the Service.
- Telemetry data: anonymized analytics and error reporting collected through tools such as Sentry, Hotjar, and Google Analytics. All telemetry is implemented with anonymization measures to ensure that no personal or sensitive content entered by users is captured.

We do not collect other categories of personal data unless voluntarily provided by you for support or contact purposes.

3. How we use your information

- To provide and maintain the Service.
- To authenticate you as a user.
- To communicate with you about your account and the Service.
- To monitor, analyze, and improve the performance, stability, and usability of the Service (using anonymized telemetry).

4. Processing of user content

The Service allows you to submit content ("User Content") for the purposes of preparing translations, text analyses, and other features for which the Service was designed.

User Content is:

- processed only for the duration necessary to generate the requested output;
- not stored beyond the immediate processing operation;
- not included in telemetry logs or error reports.

Third-party commercial APIs and hosting providers used include:

- OpenAI for natural language processing and generative AI.
- Anthropic (Claude) for natural language processing and generative Al.
- DeepL API for translation services.
- Microsoft Azure for cloud hosting and infrastructure.
- OVH for cloud hosting and infrastructure.

These providers process your data solely to provide the requested output and do not use User Content to train their models or improve their services.

5. Legal basis for processing

- Contract performance where processing is necessary to provide the Service you have requested.
- Legitimate interest in analyzing anonymized usage data to improve the Service and ensure stability.
- Consent where required for specific functionalities.

6. Data sharing

We do not sell or rent your personal data. We may share data only with:

- Third-party service providers who process data on our behalf (e.g., hosting, telemetry, API processing), under contractual safeguards.
- Authorities, if required by law.

7. Data retention

- Personal data (such as your name and email) is retained only as long as necessary to operate your account and provide the Service.
- User Content submitted through the Service is not retained beyond the immediate processing necessary to generate results.
- Telemetry logs do not capture the content or responses of your inputs.
- Anonymized telemetry data may be retained in aggregated form for statistical and performance analysis.

8. International data transfers

Your personal data may be transferred to and processed in countries outside the European Economic Area (EEA), where data protection laws may differ. When we do so, we ensure appropriate safeguards are in place, such as the use of Standard Contractual Clauses.

9. Data security

We implement appropriate technical and organizational measures to protect your personal data against unauthorized access, alteration, disclosure, or destruction.

10. Your rights

Subject to applicable law, you may have the following rights:

- Access your personal data.

- Request deletion of your personal data.
- Object to certain processing activities.
